Transport for Testing Samples, will be the focus for 2021 in Midwest Cannabis Markets

Blue Diamond Ventures Inc. confirms the acquisition of the goPronto™ technology solution for use as a multi-state approved transport service of Cannabis and Cannabis Products. The transport solution will initially be used to track and trace samples collected for testing by the H360 Labs installation in Chillicothe, Missouri, and then rolled out in Illinois and Michigan later this year.

“We have decided to integrate the goPronto™ solution into the Trademark & Licensing package that is being sold to lab operators by H360 Labs” said Josh Alper CEO of BLDV “We have been doing research with Kansas State University on post harvest freshness, this is part of the overall testing solution as bags and containers used for transport of samples must preserve the product in its original state”.

As markets become more mature, delivery and transport solutions are moving into the forefront of the industry. “I like the fact that this is now a part of the H360 Labs package ” said David Serrano, Chief of Business Development for the group, “This solution will help us greatly when operation in Puerto Rico fully launches later this year.”

Part of the cannabis transport solution will be the introduction of the first ever **Air Transport** for testing samples in Missouri. By using the network of smaller airports around the state, H360 Labs will be able to provide testing services for all cultivators and processors in the state. This service is pending state and local approvals, but promises to be a game changer for rural producers.
