The company continues to facilitate website orders for plant-based prepared meals and plants throughout Canada and the United States. The company continues to expand its delivery capabilities to Central and Eastern Canada.

The company changed its name from Vegaste Technologies Corp to PlantX Life Inc. to keep the branding consistent with all of the Company's offerings.

The company entered into an agreement to acquire Bloombox Club UK for £8 million. This acquisition will expedite the delivery offerings for PlantX in the UK market.

Management is continually looking for partners to form strategic alliances with in order to add the new partner onto the website platform. Management is also looking for other wholesale customers in Canada and the United States

The company is working on its first flagship store to present the plant-based offerings that are listed on the company's website.

The company partnered with Marche Tau to provide access to plant-based vitamins, supplements and groceries across Canada. Marche Tau will also use their white label connection to help PlantX build out its own product line that includes plant-based vinegar, sauces, spreads, tapenades, rice, risotto, soup, coffee, olive oil and will continue to increase the offerings in time.

The company partnered with Los Angeles based chef Gregg Drusinky to create a rotating plant-based menu for meal delivery in Canada. PlantX.ca has already added Harissa Carrots and Eggplant "Parm" Lasanga to the menu and will be adding eight more items in the next 2 to 3 months.

The Company has agreed to acquire Bloombox Club Limited ("Bloombox Club UK") a leading UK-based e-commerce platform that sells and delivers indoor plants to their established wellness community via subscription service and online shop. The Company will acquire Bloombox Club UK for an aggregate purchase price of £8 million to be satisfied by a combination of £560,000 in cash and £7,440,000 in common shares in the capital of the Company ("Common Shares"). An aggregate of 10,782,559 Common Shares will be issued as consideration based on a deemed price of C\$1.17 per share, that being equal to the immediately preceding 10 day volume weighted average trading price of the Common Shares (the "Consideration Share Price").
