Additionally, counsel has personally conferred with I. Richard Garr the Company’s CEO, and directors Dr. Barry Ginsberg, Paul Michaels, and Michael Fish, and discussed the information contained in the Company’s disclosure statements.

The opinions and conclusions contained in this Opinion Letter are based upon documentation and facts made available to this firm and are solely based on the accuracy of those documents

and facts. Further, counsel has reviewed all prior disclosures posted by the Company with OTC Disclosure and News Service, as amended and the Company. The Company has 205,000,000 (Two Hundred Five Million) Preferred shares authorized with 134,109,750 Series A Preferred, 293,000 Series B Preferred shares, and 30,000,000 Series C Preferred shares outstanding. The Company's fiscal year end is December 31.


The Company states that it is not a shell company as defined in Rules 405 of the Securities Act of 1933 and 12b-2 of the Securities Exchange Act of 1934.
