You are entitled to rely on this letter in determining whether Hybrid Fuels, Inc., ("*Company*") has made adequate current information publicly available within the meaning of Rule 144c(2) under the Securities Act of 1933 ("*Securities Act*").

The undersigned is a resident of the United States. Our office has been engaged by the Company to be its special securities counsel. Our services include preparing or reviewing disclosure information and press releases, interfacing with the chief financial officer and independent accountants, and giving general legal advice to management. We have examined such corporate records and other documents and have asked such questions of law as we have considered necessary or appropriate for the purpose of writing this letter. We have relied on publicly available information from the Secretary of State of the State of Nevada and information obtained from the Company's officers and directors. We have also reviewed the following documents posted at www.OTCMarkets.com and publicly available through the OTC Disclosure and New Service in connection with the preparation of this letter; (i) the Company's Quarterly Information and Disclosure Statement posted on December 12, 2011 and the Company's Financial Statements for the period ended September 30, 2011 posted on December 12, 2011; (ii) the Company's Initial Information and Disclosure Statement posted on June 2, 2011; (iii) the Financial Statement for the years ended March 31, 2009 and 2008 posted on June 2, 2011; (iv) the Financial Statements for the years ended March 2011 and 2010 posted on June 2, 2011; and (v) the Company's Articles of Incorporation, and the Company's Bylaws each posted on June 2, 2011 (the "*Information*"). We believe the sources we have relied upon are reliable.

Our letter relates to the laws of the United States, specifically the Securities Act and the corporate laws of the State of Nevada. The undersigned is member in good standing of the bar of the State of Illinois since 1997 and is permitted to practice before the Securities and Exchange Commission ("*SEC*") and the undersigned has not been prohibited from practice thereunder.

The Company is not a reporting issuer under the Securities Exchange Act of 1934 ("*Exchange Act*") and, therefore, does not file periodic reports with the SEC.

This Information constitutes, in our opinion, adequate current public information concerning the Company's securities and is available within the meaning of Rule 144(c)(2) under the Securities Act. It includes all of the information that a broker-dealer would be required to obtain from the Company to publish a quotation for the securities under Rule 15c2-11 under the Exchange Act and complies as to form with the OTC Market's Guidelines for Providing Adequate Current Information version 10.0 updated on 1/14/2011, which are located on the Internet at www.OTCMarkets.com and has been posted through the OTC Disclosure and News Service.

The person responsible for the preparation of the Company's financial statements is Mr. Ramiro Cadena. He is qualified to prepare the financial statements because Mr. Wheeler's experience and knowledge of accounting qualifies him to prepare the company's un-audited financial documents. The financial statements have not been audited.

The Company's transfer agent is Standard Registrar and Transfer Company, Inc. which is registered with the SEC. The method used to confirm the number of outstanding shares of common stock set forth in the Information Statement was to contact the transfer agent and receive written confirmation as to the number of outstanding shares.

The undersigned has personally met with management and all of the directors of the Company. The undersigned has reviewed the Information Statement, as presently published by the Company through the OTC Disclosure and News Service. The undersigned discussed the disclosed information with management and all of the directors of the Company.

To the best of my knowledge, after inquiry of management and the directors of the Company, neither counsel nor any officer, director or 5% or greater holder of the outstanding securities of the Company is currently under investigation by any federal or state regulatory authority for any violation of federal or states securities laws.

No person other than OTC Markets Group, Inc. is entitled to rely on this letter. However, the undersigned hereby grants the OTC Markets Group, Inc. full and complete permission and rights to publish this letter in the OTC Disclosure and News Service for viewing by the public and regulators.
